Security Policy Statement: -

Purpose: -

Main Lines of action: -

To achieve its security goals, KVGGN Synergy promotes the following fundamental principles in all its corporate and operational activities.

- Identify security risks related to KVGGN Synergy, define preventive actions, foster continuous improvement, and maintain awareness of the security situation within the company.
- Comply with the relevant security laws of the countries in which it operates, while fully respecting human rights.
- Collaborate with, and not interfere with, public security authorities in the discharge of their legitimate duties, all while upholding the core principles.
- Provide training in human rights to all security personnel under the direct control of KVGGN Synergy, or ensure that such personnel have received proper training in the relevant areas.
- Avoid the use of force in security operations, employing it only when absolutely necessary, and always in accordance with the law. Any use of force should be proportional to the threat faced and aimed at protecting life.
- Regularly evaluate security providers throughout the duration of their contract, with the aim of identifying areas for improvement.
- Ensure and strengthen the proper qualifications of all security personnel, both internal and external, by establishing rigorous training programs and basing hiring requirements on past performance and the adaptation of appropriate standards.

- Ensure the protection of personnel, assets, intellectual property, and other sensitive information, as well as the smooth continuation of its activities.
- Implement controls over the company's inflows and outflows of information to prevent the leakage or theft of sensitive data, whether accidental or intentional.

- Integrate security management into broader stakeholder engagement, ensuring that the concerns and needs of local stakeholders are considered when planning security activities.
- Develop a proactive security strategy aimed at minimizing both physical and digital security risks, including cybersecurity threats and industrial espionage, and ensure the allocation of adequate resources for its successful implementation.
